## Bicycle & Equipment Rental Agreement

**\*\*Please Read Carefully Before Signing\*\***

**The term "equipment" used in this agreement is any and all products leased by Sandy Beach Outfitters.**

I understand that bicycling is a hazardous activity. **I understand that the sport of cycling and its use involve a risk of injury to any and all parts of the user's body.** I hereby agree to freely and expressly assume and accept any risk and all injury while bicycling. A helmet is provided with each bike rental and its use is recommended. If the bikes were delivered and you would like one please email [SeasideScooterSC@gmail.com](mailto:SeasideScooterSC@gmail.com) or call and we will make sure to get you one.

I have examined the equipment and found it to be in good condition and will return it in the same condition as when I received it, ordinary wear and tear is accepted. I will report and return at once, to Seaside Scooters and Bikes or call if any equipment is not functioning normally.

I agree that I will release Sandy Beach Outfitters, LLC from any and all responsibility of liability for injuries or damages to the user of the equipment listed on this form or to any other person. I agree not to make a claim against or sue Sandy Beach Outfitters, LLC for injuries or damages relating to bicycling or the use of this or any equipment.

The equipment at all times remains the exclusive property of Sandy Beach Outfitters, LLC. **The renter is responsible for damage to or loss of any equipment.** If the equipment is lost, destroyed or damaged beyond repair, the renter agrees to pay full retail value of the equipment, plus 20%. Any repairs needed as a result of neglect to the equipment, including flats, broken umbrellas, water equipment etc. will be performed at a normal labor rates and the cost of such repairs, including parts, shall be paid by the renter. No refunds will be given on any equipment returned early for any reason once accepted, including inclement weather. (Hurricanes Excluded)

I hereby accept the terms of this contract. This document constitutes an agreement between Sandy Beach Outfitters, LLC and the undersigned. Sandy Beach Outfitters, LLC does not provide warranties, expressed or implied and the equipment is accepted "as is". I have carefully read this agreement and release Sandy Beach Outfitters of all liability and fully understand its contents. I am aware this is a release of liability and a contract between me and Sandy Beach Outfitters, LLC and I sign it on my own free will.
